## Early Education

In a time of national ferment, much attention is being placed on the need for quality early education to ensure that all students enter first grade ready to learn. For the **Jessie B. Cox Charitable Lead Trust**, the family grants committee and its GMA team engaged in discussions with the Nellie Mae Foundation, New England’s most prominent education foundation. Our sessions led to fruitful grantmaking partnerships with other funders and with state and national government. In Vermont, the Trust joined a large funder collaborative to seed-fund universal pre-kindergarten in 11 towns, with the

promise of state funding to continue these programs in future years. In Vermont, Maine, and New Hampshire, the Cox Trust supported state early learning councils to apply for and receive \$2 million in new federal grant funds to coordinate, expand, and improve the quality of preschool options, especially for low-income children.

## Elder Affairs, Fishing Communities

True to its 19th century origins as a rest home for retired seamen, **Sailors’ Snug Harbor of Boston** is a leader in funding elder programs and in providing support for coastal families affected by the decline of the fishing industry. The trustees annually convene the grantees in their two program areas for convivial and informational sessions featuring experts in their fields. In 2010 Massachusetts Senator Patricia D. Jehlen, Senate Chair of the Joint Committee on Elder Affairs, led a question-and-answer session on legislative initiatives affecting older adults with the foundation’s Elder Program grantees, and Jen Levin from the Gulf of Maine Research Institute engaged Fishing Initiative grantees with a thought-provoking presentation on the evolution of the sustainable seafood marketplace.

## Evaluating Programs for Disadvantaged Families

The directors of **The Linden Foundation** realized that the usual approaches to program evaluation seemed not to apply to their grantees—community-based organizations that strengthen disadvantaged and homeless families by providing sustained and holistic support to address the challenges facing multiple family members. Working with the trustees, GMA Foundations coordinated a conversation on what really works in these important programs with Katya Fels Smyth, founder of the Full Frame Initiative and invited trustees of several other like-minded foundations to join. Rather than isolate outcomes, her “full frame” continuum for society’s neediest includes access to resources, decreased social isolation and exclusion, safety, stability, and increased mastery and self efficacy.

## Social Entrepreneurs in Third World Countries

In 2010, philanthropy continued its lively discussion about social entrepreneurs and market-based approaches. The grantees of the **Conservation, Food & Health Foundation** were well-represented on this front. Farmers in Rwanda are working to improve their methods in a crucial effort to reclaim the land. Beginning with 40 farmers in Kenya, the One Acre Fund is now working with nearly 30,000 farmers in both Kenya and Rwanda to reverse the rampant soil depletion and erosion with improved seeds, fertilizer and water management techniques. The prospects for increased crop yields are promising if not yet reality. One Acre and several other organizations supported by the foundation were recognized for their innovative work by media sources including Time Magazine, Scientific American, the Huffington Post, and Seed Magazine.

## New Leadership

Established in 1944, **The Theodore Edson Parker Foundation** is an independent foundation operating with a longstanding commitment to the city of Lowell, Massachusetts. This year the foundation added two new board members, including Lowell resident, Sophy Theam, whose experience in philanthropy began as a Parker Foundation Fellow, a program overseen by GMA Foundations staff. A local banker and community activist, she is the first Cambodian American to sit on a foundation board. Sophy and David W. Donahue, an investment advisor in Boston, succeed Thomas Leggat following his 32 years of valued service.

## Employee Engagement

Established by the law firm of Foley Hoag LLP, **The Foley Hoag Foundation** is committed to the improvement of race relations in the city of Boston. Consistent to its original charter, only one of the three trustees is a partner of the firm. GMA facilitated a proposal-review training program for firm associates. This process serves to orient new lawyers to Boston and to the firm’s commitment to the practice of philanthropy.

## Family Succession

The engagement of future generations in the life of a family foundation is one of the greatest challenges in philanthropy. Five years of succession planning, next generation training and orientation led to the first meeting of the three-generation board of the **Howard and Geraldine Polinger Family Foundation**. GMA consultants worked with the first, second and third generations of this Washington, D.C. based foundation to implement the succession plan and to facilitate the first multi-generational planning meeting.

## Paperless Review

With trustees in 19 states, and a mission to advance the work of practicing physicians and to improve the quality of healthcare for all Americans, the national **Physicians Foundation** was eager to migrate from voluminous paper materials to iPads for trustee meetings. GMA staff helped

## Collaborative Review

The directors of the **Clipper Ship Foundation** have always assumed full responsibility for proposal review and their paper volume has been weighty. Thanks to GMA's new Foundant application database, they can now review proposals remotely and enter their comments and recommendations directly into the database. GMA developed a new review template that resulted in the reduction of paper, cutting the volume of the trustee meeting book by nearly half.

## Supporting A Foundation Merger



The **Life is good Kids Foundation** helps children overcome life-threatening challenges, including violence, illness and extreme poverty. When the Foundation merged with Project Joy, a Boston-based grassroots charity, GMA financial staff stepped in to help the organization stay on top of increased financial reporting needs. This allowed the directors

and staff to dedicate more time to grantmaking and to helping children through its Life is good Playmakers initiative, which trains and supports frontline child care professionals who engage in healing, transformational play with the children in their care.


- Client site visits and briefings with nonprofit leaders. GMA Foundations staff of 20 conducted well over 100 site visits to meet with nonprofit organizations throughout New England and participated in dozens of field briefings and collaborative discussions with colleagues.
- Regular office hours for nonprofit organizations through the GMA Open House series increase the accessibility of foundation staff and close the communications gaps between grantors and grantees. In 2010, 60 organizations visited GMA for an informal discussion about the field of philanthropy with GMA staff and an overview of grantmaking at GMA.




- Ongoing engagement in funder collaboratives, in fields of interest including education, violence prevention, civic engagement and the arts.

# GMA By The Numbers


**Total Grants \$29,659,612**
